#### TERMS AND CONDITIONS

#### WARRANTY

COMMUNITY WARRANTS TO THE ORIGINAL PURCHASER THAT EACH PIECE OF FURNITURE WILL BE FREE FROM DEFECTS IN WORKMANSHIP GIVEN NORMAL USE FOR FIVE YEARS. PRODUCTS USED IN MULTIPLE SHIFT APPLICATIONS INCLUDING BUT NOT LIMITED TO RESTAURANTS, CASINOS, NIGHTCLUBS, ETC. ARE WARRANTED FOR TWO YEARS. CASTERS ARE WARRANTED TO BE FREE FROM DEFECTS IN MATERIALS AND WORKMANSHIP FOR A PERIOD OF FIVE YEARS AND TEXTILES FOR TWO YEARS (WITH THE EXCEPTION OF COM/COL TEXTILES). COMMUNITY, AT ITS OPTION, WILL REPAIR OR REPLACE ANY DEFECTIVE FURNITURE WITHIN THE TERMS OF THE WARRANTY. THIS WARRANTY DOES NOT APPLY TO DAMAGE RESULTING FROM ACCIDENT, ALTERATION, OR MISUSE. GOODS OTHER THAN FURNITURE ARE SOLD BY COMMUNITY TO CUSTOMER WITHOUT WARRANTY.

#### PRICING

ALL PRICES ARE LIST AND FOB FACTORY. THIS CATALOG SUPERSEDES ALL PRICES PREVIOUSLY QUOTED AND IS SUBJECT TO CHANGE, POSSESSION OF THIS PRICE LIST DOES NOT CONSTITUTE AN OFFER TO SELL. ORDERS CAN ONLY BE RECEIVED FROM AUTHORIZED COMMUNITY DEALERS.

#### ACCEPTANCE, MODIFICATION, ASSIGNMENT

BY PLACING THIS ORDER FOR FURNITURE, MATERIAL OR OTHER PRODUCTS (SOMETIMES COLLECTIVELY REFERRED TO AS "GOODS"), CUSTOMER (AS IDENTIFIED ON THE REVERSE SIDE HEREOF OR THE INVOICE) AGREES TO THESE TERMS AND CONDITIONS WHICH SHALL PREVAIL OVER INCONSISTENT PROVISIONS IN ANY OTHER FORM OR DOCUMENT OF CUSTOMER. NO CHANGE OR MODIFICATION SHALL BE APPLICABLE UNLESS SET FORTH IN WRITING AND SIGNED BY COMPANY. NEITHER THIS ORDER NOR ANY INTEREST THEREIN SHALL BE ASSIGNED BY CUSTOMER EXCEPT WITH THE PRIOR WRITTEN CONSENT OF COMPANY.

#### **PAYMENT**

CUSTOMER AGREES TO PAY DEPOSIT OR DOWN PAYMENT AS REQUIRED BY COMPANY, CUSTOMER AGREES TO PAY TO COMPANY THE AMOUNT INDICATED ON THE INVOICE, 1% 15 DAYS, NET 30 DAYS FROM DATE OF INVOICE (U.S. FUNDS ONLY), FOR GOODS ORDERED. INTEREST WILL BE CHARGED AFTER 30 DAYS FROM THE DATE OF INVOICE AT THE RATE OF ONE AND A HALF PERCENT (1.5%) PER MONTH. INTERNATIONAL SALES WILL REQUIRE ADDITIONAL PAYMENT ARRANGEMENTS. NO GOODS SHALL BE SOLD ON CONSIGNMENT OR CONDITIONAL SALES BASIS. PAYMENT FOR THE GOODS DELIVERED HEREUNDER SHALL CONSTITUTE ACCEPTANCE THEREOF.

#### **DELIVERY**

#### CLAIMS

ALL SHIPMENTS ARE DELIVERED TO THE CARRIER IN GOOD CONDITION AND COMPANY'S LIABILITY CEASES AFTER ACCEPTANCE BY CARRIER. IF SHIPMENT ARRIVES SHORT OR DAMAGED, THE CUSTOMER MUST FILE A CLAIM IMMEDIATELY WITH THE CARRIER. IN THE EVENT OF CONCEALED DAMAGE, NOTIFY CARRIER AND REQUEST AN IMMEDIATE INSPECTION. KEEP ALL CARTONS AND PACKING MATERIAL. FAILURE TO FILE CLAIM WITHIN 15 DAYS AFTER RECEIPT OF GOODS CONSTITUTES ACCEPTANCE AND A WAIVER OF ANY SUCH CLAIMS.

#### ATTORNEYS' FEES

CUSTOMER SHALL BE RESPONSIBLE FOR ALL EXPENSES AND COSTS IN CONNECTION WITH THE ENFORCEMENT BY COMPANY OF THESE TERMS AND CONDITIONS AND THE COSTS OF COLLECTION (INCLUDING THE FEES OF ANY COLLECTION AGENCIES TO WHOM THE CUSTOMER'S ACCOUNT MAY BE REFERRED), PLUS REASONABLE ATTORNEYS' FEES (WHICH ATTORNEYS' FEES SHALL NOT BE LESS THAN 25% OF THE AMOUNT DUE, UNLESS A LOWER AMOUNT IS SPECIFIED BY APPLICABLE LAW).

#### DISCLAIMER OF WARRANTIES

THE EXPRESS WARRANTIES BELOW ARE THE COMPANY'S SOLE WARRANTIES OF ITS GOODS, THERE ARE NO UNDERSTANDINGS, AGREEMENTS, REPRESENTATIONS, OR WARRANTIES, EXPRESS OR IMPLIED (INCLUDING ANY REGARDING THE MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE), NOT SPECIFIED HEREIN, RESPECTING THE GOODS. EXCEPT FOR THOSE OBLIGATIONS OF THE COMPANY IDENTIFIED IN THESE TERMS AND CONDITIONS, ALL RISKS RELATED TO THE QUALITY AND PERFORMANCE OF THE GOODS AND RESPONSIBILITY FOR REPAIR OR SERVICE COSTS RESTS SOLELY ON THE CUSTOMER. COMPANY RESERVES THE RIGHT TO LIMIT THE APPLICABLE WARRANTY TO THE GOODS DEPENDING UPON THE DIVISION OR CATALOGUE THROUGH WHICH SAID GOODS WERE SOLD. SOME STATES DO NOT ALLOW LIMITATIONS ON IMPLIED WARRANTIES, LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO ALL CUSTOMERS. THIS WARRANTY GIVES THE CUSTOMER SPECIFIC LEGAL RIGHTS, AND EACH CUSTOMER MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

#### CANCELLATION

ALL CANCELLATIONS MUST BE MADE IN WRITING, ADMINISTRATIVE AND/OR LABOR CHARGES MAY BE INCURRED BY THE CUSTOMER DEPENDING UPON THE PRODUCTION STAGE OF THE ORDER, ORDERS SPECIFYING SPECIAL FINISH CANNOT BE CANCELLED ONCE FINISHING HAS BEGUN. CANCELLATIONS CANNOT BE ACCEPTED ONCE FINAL PRODUCTION HAS BEGUN.

#### ORDER CHANGES

ALL CHANGES TO AN ORDER MUST BE MADE IN WRITING AND ARE SUBJECT TO COMPANY'S ABILITY TO CONFORM. ADMINISTRATIVE AND/OR LABOR CHARGES MAY BE INCURRED BY THE CUSTOMER DEPENDING UPON THE PRODUCTION STAGE OF THE ORDER. ONCE FINAL PRODUCTION HAS BEGUN, NO CHANGES CAN BE ACCEPTED.

#### REMEDIES

THE REMEDIES HEREIN RESERVED SHALL BE CUMULATIVE AND ADDITIONAL TO ANY OTHER OR FURTHER REMEDIES PROVIDED IN LAW OR EQUITY. NO WAIVER OF A BREACH OF ANY PROVISION OF THESE TERMS AND CONDITIONS SHALL CONSTITUTE WAIVER OF ANY OTHER BREACH OR OF SUCH PROVISION.

#### INSOLVENCY

COMPANY MAY FORTHWITH CANCEL THIS ORDER IN THE EVENT OF THE HAPPENING OF ANY OF THE FOLLOWING OR ANY OTHER COMPARABLE EVENT: INSOLVENCY OF THE CUSTOMER, THE FILING OF A VOLUNTARY PETITION IN BANKRUPTCY, THE FILING OF ANY INVOLUNTARY PETITION TO HAVE CUSTOMER DECLARED BANKRUPT PROVIDED IT IS NOT VACATED WITHIN THIRTY (30) DAYS FROM THE DATE OF FILING, THE APPOINTMENT OF A RECEIVER OR TRUSTEE FOR CUSTOMER PROVIDED SUCH APPOINTMENT IS NOT VACATED WITHIN THIRTY (30) DAYS FROM THE DATE OF SUCH APPOINTMENT, OR THE EXECUTION BY CUSTOMER OF AN ASSIGNMENT FOR THE BENEFIT OF CREDITORS.

#### LIMITED LIABILITY

THE COMPANY SHALL NOT UNDER ANY CIRCUMSTANCES BE LIABLE TO THE CUSTOMER, OWNER OF THE GOODS OR ANY THIRD PARTY FOR SPECIAL, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, INCLUDING, WITHOUT LIMITATION, LOSS OF PROFITS OR REVENUES, LOSS OR DAMAGE TO OTHER PROPERTY OR EQUIPMENT, COST OF CAPITAL OR OF PURCHASED OR REPLACEMENT GOODS, OR EXPENSE, DELAY OR INCONVENIENCE CAUSED BY OR ARISING FROM THE PURCHASE, SALE, USE, REPAIR OR INABILITY TO USE THE GOODS OR BY ANY PERFORMANCE OR NON-PERFORMANCE UNDER, OR BREACH OF THESE TERMS AND CONDITIONS, THE COMPANY'S SOLE LIABILITY FOR ANY DEFECTIVE GOODS SHALL BE ITS REPAIR OR ITS REPLACEMENT PURSUANT TO THE EXPRESS WARRANTIES SET FORTH ABOVE, OR IF AMENDED, AS APPLICABLE AT THE TIME OF MANUFACTURE OR REPAIR OF THE GOODS, SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSION MAY NOT APPLY TO ALL CUSTOMERS. ANY ACTION RESULTING FROM ANY BREACH ON THE PART OF COMPANY AS TO THE GOODS OR SERVICES DELIVERED HEREUNDER MUST BE COMMENCED WITHIN ONE YEAR AFTER THE CAUSE OF ACTION HAS OCCURRED.

#### SECURITY AGREEMENT

THE COMPANY MAY REQUIRE AND CUSTOMER SHALL GRANT A SECURITY INTEREST IN GOODS SOLD PURSUANT TO ANY CREDIT THE COMPANY MAY EXTEND TO THE CUSTOMER.

#### TERMS AND CONDITIONS

#### **ALLOWANCES**

REASONABLE TOUCH-UP AND DELUXING IS THE DEALER'S RESPONSIBILITY. THE COMPANY WILL NOT MAKE ALLOWANCES FOR TRIP OR DELIVERY CHARGES, BUT WILL ONLY MAKE ALLOWANCE FOR ACTUAL WORK PERFORMED TO CORRECT MANUFACTURING DEFECTS. ALLOWANCES MAY BE AUTHORIZED ONLY BY A COMPANY OFFICER.

#### REPAIRS

INSPECTION OF GOODS UPON ARRIVAL IS MANDATORY AND ALL DEFECTS MUST BE CALLED TO THE COMPANY'S ATTENTION UPON ARRIVAL AT THE CUSTOMER'S "SHIP TO" DESTINATION. IT IS THE RESPONSIBILITY OF THE FIELD SALES REPRESENTATIVES TO INSPECT ANY DEFECTIVE MERCHANDISE AND MAKE SUGGESTIONS AND RECOMMENDATIONS AS TO THE PROPER DISPOSITION. FIELD PERSONNEL CANNOT OBLIGATE OR BIND THE COMPANY BY DEFINITE AGREEMENT, WITHOUT FINAL AUTHORIZATION BY A COMPANY OFFICER. COMPANY WILL NOT ACCEPT AUTOMATIC CHARGE BACKS WHICH DO NOT HAVE PRIOR AUTHORIZATION. TO INITIATE ANY TYPE OF CLAIM OR REQUEST FOR PARTS, IT IS IMPERATIVE TO HAVE THE MODEL NUMBER OR FABRIC NUMBER, WHICH MAY BE LOCATED ON THE TAG ATTACHED TO THE FRAME OF THE UNIT.

#### **RETURNS**

RETURNS WILL BE ACCEPTED ON ANY STANDARD CATALOG MODEL WOOD AND METAL FINISHED GOODS WITH A 45% RESTOCKING FEE. UPHOLSTERED GOODS NOT INCLUDED. ANY OTHER RETURN INQUIRIES MUST BE MADE IN WRITING TO YOUR CUSTOMER SERVICE REPRESENTATIVE.

#### REPLACEMENT PARTS

PRICES FOR REPLACEMENT PARTS CAN BE OBTAINED BY CALLING OUR CUSTOMER SERVICE DEPARTMENT. PLEASE HAVE THE MODEL NUMBER AVAILABLE WHEN ORDERING REPLACEMENT PARTS.

#### **GOVERNING LAW**

ALL DISPUTES BETWEEN THE PARTIES, WHETHER OR NOT ARISING OUT OF THESE TERMS AND CONDITIONS, WILL BE GOVERNED BY THE LAWS OF THE STATE OF INDIANA. CUSTOMER AGREES TO SUBMIT TO THE JURISDICTION OF AND AGREES ALL LAWSUITS RELATING TO ANY DISPUTES BETWEEN THE CUSTOMER AND THE COMPANY WILL BE BROUGHT ONLY IN A STATE COURT LOCATED IN DUBOIS COUNTY, INDIANA OR THE UNITED STATES DISTRICT COURT FOR THE SOUTHERN DISTRICT OF INDIANA. THE CUSTOMER HEREBY WAIVES THE RIGHT TO A TRIAL BY JURY IN ANY ACTION, PROCEEDING, CLAIM, OR COUNTERCLAIM WHETHER IN CONTRACT OR TORT, AT LAW OR IN EQUITY, ARISING OUT OF OR RELATING IN ANY WAY TO THESE TERMS AND CONDITIONS AND ALL OTHER DISPUTES BETWEEN THE PARTIES.

#### MITIGATION

IF THE COMPANY REPOSSESSES THE GOODS PRIOR TO PAYMENT BY THE CUSTOMER OF ALL AMOUNTS DUE HEREUNDER, THE COMPANY MAY SELL THE GOODS, AS IS, WHERE IS, FREE AND CLEAR OF ALL RIGHTS OF THE CUSTOMER AT EITHER PUBLIC OR PRIVATE SALE, AND APPLY THE NET PROCEEDS (AFTER DEDUCTING EXPENSES OF REPOSSESSION AND SALE) TO THE OBLIGATION OF CUSTOMER HEREUNDER. THE CUSTOMER SHALL REMAIN LIABLE FOR ANY DEFICIENCY. THE COMPANY MAY DISPOSE OF THE GOODS IN ANY COMMERCIALLY REASONABLE PLACE AND MANNER AND THE CUSTOMER WAIVES ANY NOTICE OF TIME, PLACE AND MANNER OF SALE.

#### INTEGRATION

THIS ORDER FOR GOODS, INCLUDING THESE TERMS AND CONDITIONS, ALONG WITH ANY CREDIT APPLICATION, INVOICE, STATEMENT, DEALER CONTRACT, ACKNOWLEDGEMENT, BILL OF LADING (AND ANY EXHIBITS, ADDENDA OR AMENDMENTS THERETO) OF WHICH THIS ORDER MAY BE A PART, CONSTITUTES THE SOLE AND COMPLETE AGREEMENT BETWEEN THE COMPANY AND THE CUSTOMER WITH RESPECT TO THE PURCHASE OF THE GOODS.

#### DIMENSIONS, SPECIFICATIONS AND FINISHES

# SPECIFICATIONS FOR COMMUNITY EDWARDS COLLECTION

Materials: All wood shall be thoroughly air and kiln dried to a moisture content not

exceeding 6% at the time of assembly. All exposed wood and veneer to be well

sanded and free from wormholes, pits and shakes.

**Tops:** Top sizes to be dependent upon the particular size and shape of the table ordered.

Top height from floor to be 29" standard (Juvenile height of 27" and children's height of 25" are also available). 3-ply balanced construction wood veneer tops are available. As well as high-pressure laminate top with matching wood grain pattern. Special laminates available at a slight up charge. Tops are  $1^{3}/_{16}$ " thick. Constructed with miter-joint solid lumber bands,  $1^{1}/_{8}$ " thick particle board core,

and a gator-ply backing sheet.

Edge Options: Edwards tables come with a 2" wide by  $1^{3}/_{16}$ " thick external wood rim

with a knife edge or reverse knife edge detail.

Construction: Tables are constructed using solid wood aprons and legs. Apron rails are

 $^{13}/_{16}$ " and 1" wide with a  $^3/_{16}$ " radius on the bottom edge. The legs are 2 ¾" square at the top and tapered to 1 ¾" at the bottom. Legs are eased on all edges and are equipped with adjustable glides. Aprons are fastened to tops using 1 ½" wood screws. Legs are secured to a ¾" x 5 x 5 steel plate using two  $^5/_{16}$ " x 3" bolts which thread into a  $^5/_{16}$ " x 2" barrel nut embedded in the leg. The steel plate then bolts into threaded metal inserts in the tabletop using five  $^5/_{16}$ " x 1" bolts. A black metal leg option is also available. These legs are 3" in diameter and include an

adjustable glide. The metal legs also bolt to the table top.

**Finish:** Community's multi-step step finish process includes a high quality translucent

stain and clear catalyzed varnish topcoat, which enhances and protects the natural characteristic beauty of the wood. The finish combines durability and consistency

with the ease of being field repairable. Veneer tops are semi-open pore.

**Warranty:** Community warrants to the original purchaser that each table will be free from

defects in workmanship given normal use for five years of single shift service.

Tables used in restaurant applications are warranted for two years. Community will, at its option, repair any defective merchandise with the terms of the warranty.

This warranty does not apply to damage resulting from accident, alteration or

misuse.
