SPECIFICATIONS FOR COMMUNITY FINLEY COLLECTION

MODELS: 223A & C - 228A & C - 229A & C

Wood Species: Beech

Construction: Seat: Solid wood seat; 1" thick

Upholstered Grade Seat: Uph. grade plywood webbed with sheet webbing – %" All chair frames are constructed from 18 gauge metal. The joints are connected together with a mig weld. The seats are attached with screws through 4 tabs welded to the frame. The back is attached with 4 exterior screws from the

back side.

Swivel Hardware: Steel ball bearing swivel plate.

Wood Finish: Each chair has an even coat of a no-wipe stain, followed by a coat of sealer. A light

sanding is given and then oven dried for 30 minutes. Another coat of catalyzed sealer is applied and oven dried for another 30 minutes. Another light sanding process is performed to assure a smooth finish. Then the product is sprayed with a 45 sheen

catalyzed lacquer and oven dried for an additional 30 minutes. Then there is a 30

minute cool down period before final inspection.

Hardware: Each chair is equipped standard with 1 ¼" clear K-resin rocker glides.

Metal Finish: Each frame is thoroughly cleansed of contaminates with a phosphorus bath and

dried in an oven. A powder coat is applied to the frame and dried in an oven.

Upholstery: Each seat is upholstered with 2" high density polyurethane in a pneumatic press

to assure consistency in thickness and comfort. All upholstery materials pass the

California Fire Retardant Code, Class 1, Commercial Standard 191-53, and

Technical Bulletin #117.

INSOLVENCY

COMPANY MAY FORTHWITH CANCEL THIS ORDER IN THE EVENT OF THE HAPPENING OF ANY OF THE FOLLOWING OR ANY OTHER COMPARABLE EVENT: INSOLVENCY OF THE CUSTOMER, THE FILING OF A VOLUNTARY PETITION IN BANKRUPTCY, THE FILING OF ANY INVOLUNTARY PETITION TO HAVE CUSTOMER DECLARED BANKRUPT PROVIDED IT IS NOT VACATED WITHIN THIRTY (30) DAYS FROM THE DATE OF FILING, THE APPOINTMENT OF A RECEIVER OR TRUSTEE FOR CUSTOMER PROVIDED SUCH APPOINTMENT IS NOT VACATED WITHIN THIRTY (30) DAYS FROM THE DATE OF SUCH APPOINTMENT, OR THE EXECUTION BY CUSTOMER OF AN ASSIGNMENT FOR THE BENEFIT OF CREDITORS.

LIMITED LIABILITY

REPAIRS

INSPECTION OF GOODS UPON ARRIVAL IS MANDATORY AND ALL DEFECTS MUST BE CALLED TO THE COMPANY'S ATTENTION UPON ARRIVAL AT THE CUSTOMER'S "SHIP TO" DESTINATION. RETURNS WILL BE ACCEPTED ON ANY STANDARD CATALOG MODEL WOOD AND METAL FINISHED GOODS WITH A 45% RESTOCKING FEE. UPHOLSTERED GOODS NOT INCLUDED. ANY OTHER RETURN INQUIRIES MUST BE MADE IN WRITING TO YOUR CUSTOMER SERVICE REPRESENTATIVE.

REPLACEMENT PARTS

PRICES FOR REPLACEMENT PARTS CAN BE OBTAINED BY CALLING OUR CUSTOMER SERVICE DEPARTMENT. PLEASE HAVE THE MODEL NUMBER AVAILABLE WHEN ORDERING REPLACEMENT PARTS.

GOVERNING LAW

ALL DISPUTES BETWEEN THE PARTIES, WHETHER OR NOT ARISING OUT OF THESE TERMS AND CONDITIONS, WILL BE GOVERNED BY THE LAWS OF THE STATE OF INDIANA. CUSTOMER AGREES TO SUBMIT TO THE JURISDICTION OF AND AGREES ALL LAWSUITS RELATING TO ANY DISPUTES BETWEEN THE CUSTOMER AND THE COMPANY WILL BE BROUGHT ONLY IN A STATE COURT LOCATED IN DUBOIS COUNTY, INDIANA OR THE UNITED STATES DISTRICT COURT FOR THE SOUTHERN DISTRICT OF INDIANA. THE CUSTOMER HEREBY WAIVES THE RIGHT TO A TRIAL BY JURY IN ANY ACTION, PROCEEDING, CLAIM, OR COUNTERCLAIM WHETHER IN CONTRACT OR TORT, AT LAW OR IN EQUITY, ARISING OUT OF OR RELATING IN ANY WAY TO THESE TERMS AND CONDITIONS AND ALL OTHER DISPUTES BETWEEN THE PARTIES.

MITIGATION

IF THE COMPANY REPOSSESSES THE GOODS PRIOR TO PAYMENT BY THE CUSTOMER OF ALL AMOUNTS DUE HEREUNDER, THE COMPANY MAY SELL THE GOODS, AS IS, WHERE IS, FREE AND CLEAR OF ALL RIGHTS OF THE CUSTOMER AT EITHER PUBLIC OR PRIVATE SALE, AND APPLY THE NET PROCEEDS (AFTER DEDUCTING EXPENSES OF REPOSSESSION AND SALE) TO THE OBLIGATION OF CUSTOMER HEREUNDER. INTEGRATION

COMPANY RESERVES THE RIGHT TO SUBSTITUTE HARDWOODS DUE TO AVAILABILITY AT PRODUCTION. DUE TO THE NATURAL CHARACTERISTICS OF WOOD, ENVIRONMENTAL EFFECTS, AND MATERIAL UPGRADES, THE COMPANY CANNOT GUARANTEE EXACT FINISH MATCHES ON EXISTING GOODS PREVIOUSLY ORDERED FROM COMPANY.
