

PLYTANIUM® PLYWOOD SIDING WITH A PRIMER/SEALER TWENTY-FIVE (25) YEAR LIMITED WARRANTY



Georgia-Pacific Wood Products LLC (GP) makes the following warranty to the owner of a structure located within the continental United States who is the original purchaser of Plytanium® Plywood Siding with a Primer/Sealer manufactured by GP.

PRODUCT WARRANTY GP warrants that its Plytanium Plywood Siding with Primer/Sealer, when properly installed and finished, will not delaminate for a period of twenty-five (25) years from the date of acquisition of the siding by the original purchaser. Delamination shall be as defined for exterior plywood in Product Standard PS1-95. (Generally, delamination is the visible separation between plies that would normally receive glue at their interface and be firmly contacted in the pressing operation. A panel is considered delaminated if visible ply separation at a single glue line in such area exceeds three square inches.)

GENERAL PROVISIONS AND LIMITATIONS This warranty is in effect/applies only when the Plytanium Plywood Siding with Primer/Sealer has been properly installed, finished and maintained in strict accordance with the current published installation instructions of GP, the American Plywood Association and the paint manufacturer. This warranty applies only when the Plytanium Plywood Siding with Primer/Sealer has been subjected to normal use and exposure and has been accorded treatment which is considered good practice in the building industry regarding storage and maintenance. It does not apply to damage or defects caused by or arising from: (a) misuse or abuse; (b) other than normal use conditions such as improper storage, handling, maintenance, installation, impact with other objects; or, (c) acts of God such as fire, flood, wind, or earthquake. Specifically excluded are natural characteristics caused by weathering such as face veneer checking, leafing, shelling, splitting and broken grain. These natural weathering characteristics are not to be construed as delamination. Also excluded is wood rot or decay.

In the event that any Plytanium Plywood Siding with Primer/Sealer does not comply with the provisions of this warranty, GP will at its sole option, either: (a) repair the defective Siding; or, (b) reimburse the reasonable cost of comparable replacement panels/material for the defective panel(s) only. GP shall have no liability under this warranty for any labor costs, including the cost for removing any defective Plytanium Plywood Siding with Primer/Sealer panel(s), or for replacing or finishing such panel(s).

Any claim(s) under this warranty must be made/sent in writing by the owner of a structure who originally purchased the Primer/Sealer panel(s) within thirty (30) days after discovery of any defect covered by this warranty and before any alteration or repair is made, and sent to Georgia-Pacific Wood Products LLC, Structural Panels Division, 55 Park Place, Atlanta, Georgia 30303, so that GP can arrange for an inspection by an authorized representative of GP. GP must be given a reasonable opportunity, at least sixty (60) days from its receipt of any such claim(s), to inspect the purported defective panel(s) prior to any alteration or repair being made. GP shall not be liable for any cost of repair or replacement which is not authorized in writing by GP.

THIS WARRANTY SETS OUT THE ENTIRE LIABILITY OF GP WITH RESPECT TO THE PRODUCT NAMED ABOVE. THE DURATION OF ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PARTICULAR USE ARE LIMITED IN TIME TO THE DURATION OF THE EXPRESS WARRANTIES STATED HEREIN. UNDER NO CIRCUMSTANCES WILL GP BE LIABLE FOR INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES ARISING OUT OF ANY CLAIM BASED ON NEGLIGENCE, TORT, BREACH OF WARRANTY, CONTRACT, STRICT LIABILITY, OR ANY OTHER BASIS/CAUSE OF ACTION, AND SUCH DAMAGES ARE SPECIFICALLY EXCLUDED HEREIN.

Some states do not allow limitation on how long an implied warranty lasts and/or the exclusion of damages, so the above limitations and/or exclusions may not apply to you (the original owner of a structure who is the original purchaser of Plytanium Plywood Siding with Primer/Sealer). This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
