ONE YEAR LIMITED WARRANTY

Accord 15® Products



When used for approved exterior applications.

Warranty Against: Failure of Coating Integrity (peeling, cracking, flaking, splitting)/Excessive Chalking/Excessive Fading

WARRANTY: APCO Graphics, Inc. provides the user/purchaser the following 1-year limited warranty with respect to its completed, factory decorated, standard Accord 15 products under normal use as designed and with exposure of no greater than 90 degrees vertical:

If, during the first one (1) year following shipment of any such Accord 15 product, when used as described herein, such product:

- fades or chaulks to the extent that it is not effective for its intended purpose when viewed at normal viewing distances.
- the coating integrity fails from substantial peeling

then APCO will at its option, either: (1) refinish or otherwise repair the signs so as to correct such defect or (2) provide a new duplicate sign in exchange for the original upon payment by user/purchaser to APCO of an amount equal to APCO's current published price for such new sign panel plus freight less a credit against such price equal to 1/60th of the purchase price and freight charges of the original Accord 15 product for each month remaining in such initial one (1) year period.

EXCLUSIONS: No repair or replacement will be made for any Accord 15 beyond the initial one (1) year, or which has been subjected to improper usage, accidents, negligence, willful mishandling, chemical damage, improper decorating or repair by others, salt spray, fumes or vapors from indoor swimming pools, fumes or vapors directly applied to the products or in the atmosphere, spray from lawn sprinklers or landscape irrigation systems, normal wear and tear, vandalism, or failure to provide reasonable and necessary maintenance of the product. Warranty is void if modifications or alterations are made by others. Warranty is not transferable. If applicable, warranty does not apply to posts, pedestals, mounting devices, hardware or glazing. Warranty does not include the Accord 15 plastic end clips or paper inserts which may be used with the Accord 15 Insert Slot components. Warranty does not cover damage caused by faulty or improper installation or application of the product, settlement, distortion, warping, failure or cracking of the materials to which the product is mounted or attached, bending or twisting of the support structures or cabinet, earthquakes, hurricane, tornado cyclone, gale, lightning, fire, flood, wind-borne objects, ice and hail damage, weather incidents of a catastrophic nature or Acts of God. Warranty does not cover any components of the sign which are provided by a manufacturer other than APCO or one of APCO's suppliers for that particular job, including graphics, insert material, cabinets, structures, etc... Warranty applies solely to products manufactured in USA by APCO Graphics, Inc.; sold and in use within the continental United States, Alaska, Hawaii, Puerto Rico, and Canada.

LIMITED LIABILITY: APCO's sole liability with respect to such Accord 15 products, whether based on breach of warranty, breach of contract, negligence or other claim, will be to repair such product or to replace. APCO SHALL IN NO EVENT BE LIABLE FOR INDIRECT, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND, NOR FOR LABOR, REMOVAL OR INSTALLATION COSTS. APCO reserves the right to discontinue or make changes in products if a product warranted therein is not available to make a replacement hereunder. APCO reserves the right to substitute an APCO product which it considers to be suitable and of substantially equal quality.
