Recommended Use

The Four-Space Locker provides tidy storage space for children's coats and boots. The broad lower shelf is an excellent place for children to sit while putting on shoes or boots.

▲ WARNING

▲ This product is intended for use by children of immature judgement. Therefore supervision is required at all times.

▲ CAUTION

▲ For indoor use only. This Locker is not water-proof.

Cleaning

Clean Locker with soap and water. Too much water will harm the finish of the wood. Baskets are machine washable.

Installation of your Locker

This item should be fastened securely to the wall or floor. Enclosed for that purpose are:

1. Four $\frac{3}{4}$ " x #8 oval head screws.
2. Four $1\frac{1}{2}$ " x #8 oval head screws.
3. Two 2" corner braces.

The $\frac{3}{4}$ " screws are for the side or top of the Locker. The $1\frac{1}{2}$ " screws are for the wall or floor, but if not suited to the building construction, fasteners appropriate to the construction must be used. The corner braces should be mounted at either of the locations shown, on both sides of the Locker.

▲ WARNING

▲ Any locker configuration must be installed by a competent carpenter or maintenance person to ensure stability. Lockers installed back-to-back must be fastened together for stability. The customer must assume full responsibility that the locker(s) will be secure for the long term.

If your shipment is incomplete, please contact Customer Service.

Maintenance

Periodically inspect for cracks, breaks, loose parts, missing parts, and/or malfunctions. Remove the product from service when any condition develops that might make operation unsafe.

Construction

The wooden components are manufactured from solid maple and hardwood plywood, with a clear nontoxic finish. All edges and corners are rounded for safety and ease of cleaning. The coat hooks are tough ABS plastic.
