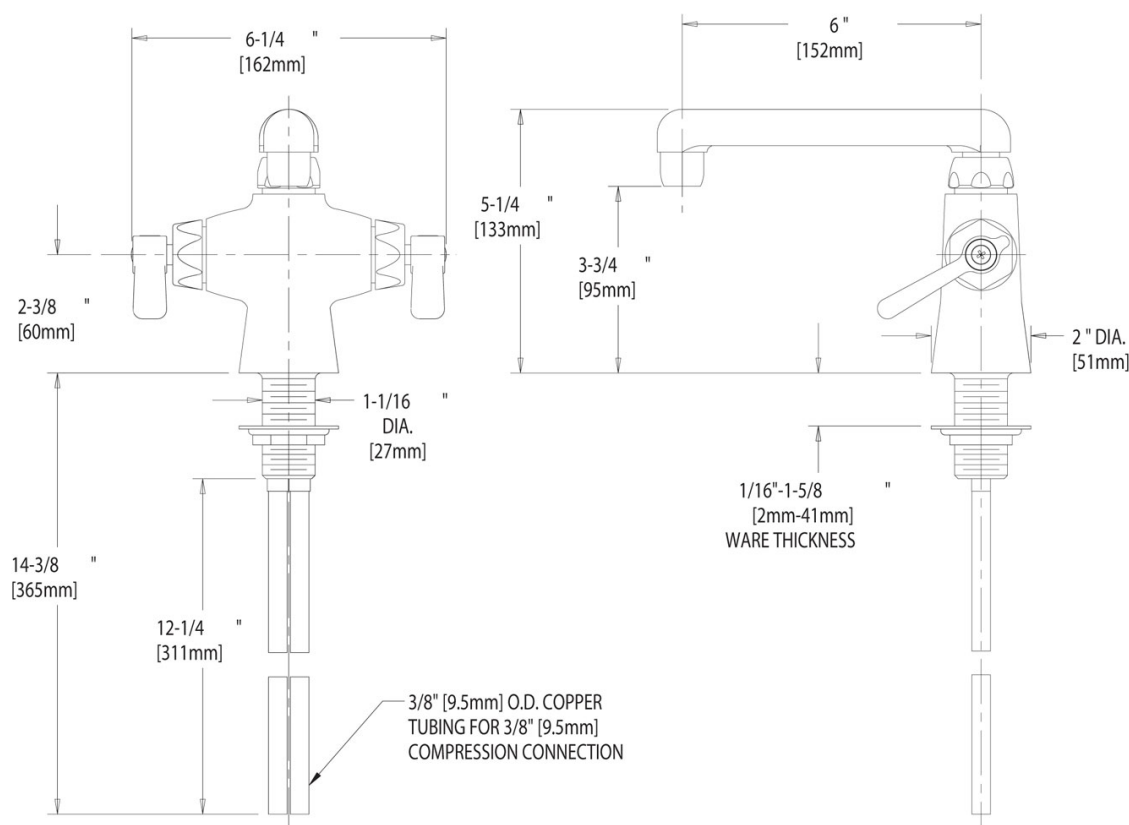

ECAST® construction with less than 0.25% lead content by weighted average. CALGreen Compliant. Operation and Maintenance
