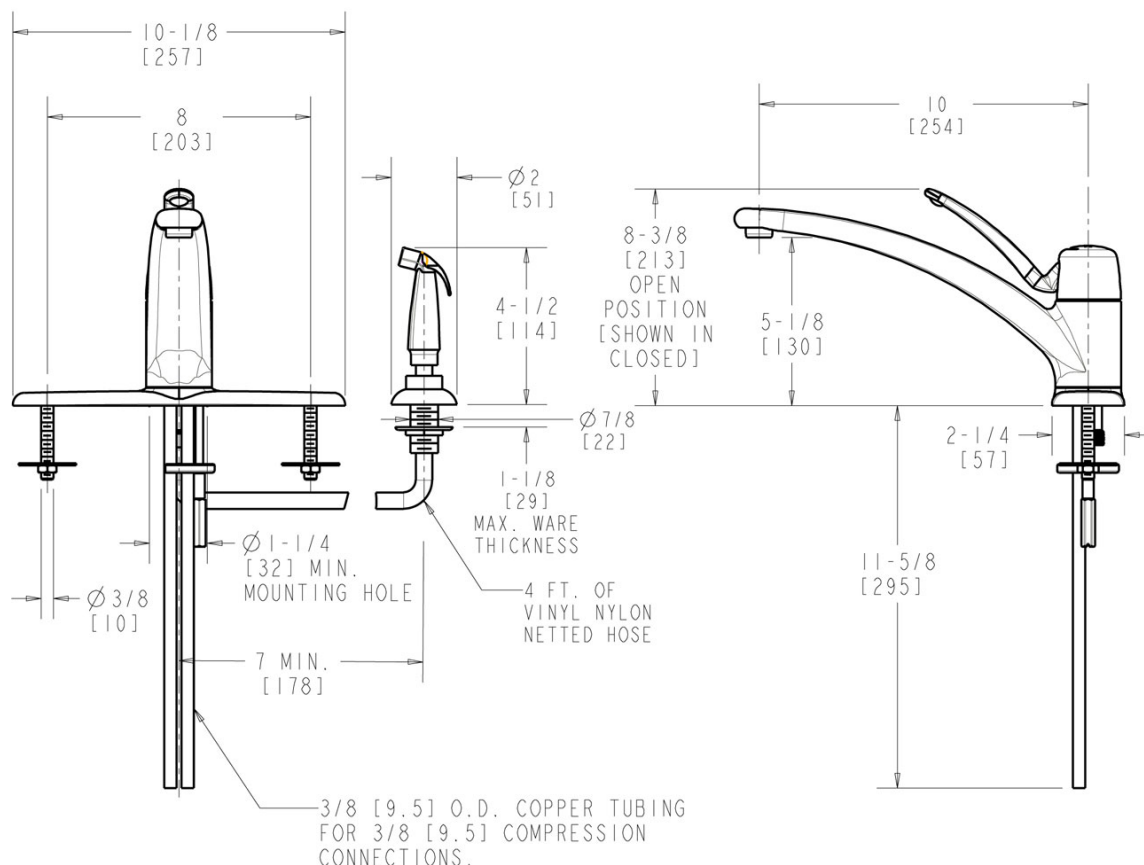

Operation and Maintenance
