ANSI (American National Standard Institute) / **NEMA** (National Electrical Manufacturers Association) Publication LD3, latest edition - Standard of the High Pressure Decorative Laminate Industry, used to maintain the quality of product.

Underwriters Laboratory Inc. - A recognized independent testing service for product classification. U.L. does not certify or approve any products. They do, however, rate products and list them. It is up to the individual code authority to set standards for a particular application. Unbonded condition is not usually reported. Since Decorative Laminate is not used unbonded, Underwriter's Laboratory only numbers those for the unbonded condition. U.S. Coast Guard 164.012

Specification for all laminate used on passenger vessels, registered in the U.S. or picking up passengers in U.S. ports. Horizontal Fire-Rated Grade only.

F.A.R. 25.853 Airplanes

Interior trim on passenger planes carrying more than six passengers requires Fire-Rated Grade.

Mobile Home Safety Standard #280 HUD

Refers to interior finishes used in mobile homes. Unless otherwise specified, all surfaces can use G.P. (General Purpose) grade. Fire-Rated Grade must be used for areas within 6 inches of range top or walls and door of furnace closet.

Motor Vehicle Safety Standard #302



CERTIFICATIONS AND APPROVALS

Federal standard applies to interiors of passenger cars, trains, and buses. Normal G.P. 50 - General purpose grade - will meet this standard. Laminate order should request "Certification of Compliance."

National Sanitation Foundation - Standard 35

Nevamar general purpose, fire rated and postforming laminates comply for work contact surfaces. Visit www.nsf.org for complete listing.
