Packaging has large amounts of recycled content – an average of corrugated material, where corrugate is used. Packaging materials, plastic banding and skids can be recycled at the jobsite if requested.

Wherever possible, blanket wrap is used thereby eliminating the packaging waste. These packaging options help to support LEED NC & CI – MR 2.1 and MR 2.2 *Construction Waste Management* or LEED EB - MR Prerequisite 1.1 *Source Reduction and Waste Management*.
